### NEW SALES TAX RATES FOR IBERVILLE PARISH

Please be advised that the sales tax rates levied in Iberville Parish will increase by .333% beginning January 1, 2008. This will change the local sales tax rate for Iberville Parish (except City of St. Gabriel corporate limits) to 4.666% and the local sales tax rate within the City of St. Gabriel corporate limits to 5.000%.

These rate changes are reflected on the 2008 Sales and Use Tax Reports in Column A 4.666% (Parishwide - School Board and Iberville Parish Council tax rates) and Column B 5.000% (Parishwide and City of St. Gabriel tax rates).

The breakdown of sales and use tax for Iberville Parish is as follows:

2.666% Iberville Parish Council  
2.000% Iberville Parish School Board  
0.333% St. Gabriel

Taxpayers will be provided 2008 sales and use tax reports to submit their sales taxes prior to the end of the current year.

**It is essential that all registers be properly programmed to calculate the new tax rates beginning January 1, 2008.**


Please reprogram all registers and tax software to properly calculate the new tax rate for the City of St. Gabriel corporate limits to 5.000% beginning January 1, 2008.
